Tuition and fee bills are online only. Students access bills through <u>ucdenver.edu/UCDAccess</u>.

• A nonrefundable 2.85% service fee applies to all debit/credit card payments. There is no fee for online payments from checking or savings accounts.

• Excess financial aid funds are refunded via direct deposit into your bank account, or a paper check is mailed to the postal address listed in your UCD Access Portal. Remaining Parent PLUS loan funds may be refunded to you or the parent depending on what your parent selected on the loan application.

• Direct deposit refunds may take approximately 3 to 5 business days from when a credit balance is created on the student's account. Paper check refunds are processed weekly on Tuesdays and Thursdays and mailed to the mailing address in the UCD Access Portal.

• Payment Plan auto-debit/auto-withdrawal will occur on the next business day if the 20th of the month falls on a weekend or holiday. Dates listed above are subject to change.
